**WAIVER OF RELEASE & LIABILITY**

I knowingly and voluntarily agree to the terms and conditions outlined in this release and waiver of liability ("W aiver"). In exchange for being permitted to participate as a volunteer at the ShopRite LPGA Classic Presented by Acer ("Tournament") and all related events, I acknowledge and/or agree to:

I, for myself, my heirs, my executors, my administrators, and my trustees, waive and release any and all rights and claims for any injuries and damages, including, but not limited to demands or actions for negligence, premises liability, emotional injury, intentional conduct, tort claims, and any other actions or demands of whatsoever nature, I have or may have against the ShopRite LPGA Classic Presented by Acer, ShopRite, Eiger Marketing Group, LLC, Stockton Seaview Hotel & Golf Club, its affiliates, subsidiaries, related entities, its parent company and all of its officers, directors, representatives, volunteers, agents, and employees and all sponsors of any Tournament events (collectively the "Released Parties") in which I may participate in whether my participation is as a volunteer and/or spectator at any of these events and I voluntarily assume these risks.

In consideration of LPGA services in co-sponsoring the Tournament, I hereby grant and assign to LPGA, without limitation, my individual television, radio, motion picture, photographic and all other similar rights with respect to my involvement at the Tournament, with the understanding that LPGA use thereof shall be limited to the following: (1) advertising, promoting, or publicizing the Tournament or any broadcasts thereof; (2) live broadcasts during the Tournament; and (3) broadcasts or exhibitions on a recorded basis as part of a program or motion picture of the Tournament, or year-end summaries or sports awards programs, or any news or sports news programs. I agree to refrain from any action, which will interfere with LPGA ownership of the rights hereunder granted and assigned to LPGA, or with any authorized use thereof.

I am in good health and have no physical conditions that affect my ability to participate as a volunteer and have not been advised otherwise by a medical practitioner. In connection with any injury or other medical conditions I may experience during and after the Tournament, I hereby consent to receive medical treatment deemed necessary by medical personnel if I am not able to act on my own behalf. I agree not to sue any applicable medical practitioners who may provide medical treatment to me for malpractice.

If I operate a Tournament golf car, I acknowledge, agree, and represent as follows: (a) I am at least eighteen (18) years of age; (b) I possess a valid driver's license; (c) I will operate the golf car in a safe manner; (d) I will complete any necessary paperwork regarding an accident; (e) I will not have a right to a claim against the Released Parties in the event of accident, which causes injury and/or death while in possession of the golf car, unless solely caused by the gross negligence of the Released Parties; and (f) I will reimburse the Tournament for the cost of the repair of any damage and/or be liable for any injury to persons caused by me while in possession of the golf car.

This waiver is a legally binding agreement and will be construed broadly to provide a release and waiver to the maximum extent permissible under applicable law. Any provisions found to be void or unenforceable shall be severed from this waiver and not affect the validity or enforceability of any other provisions. I have read this W aiver and I understand its content. I understand that by signing, I have given up substantial rights. I have voluntarily signed this W waiver.

My signature below certifies that I have read and agree to the terms outlined in the volunteer waiver above. I also acknowledge and agree that the ShopRite LPGA Classic Presented by Acer may undertake a background check required by specific volunteer positions. If needed, I understand that the Tournament will request my motor vehicle record and criminal history in connection with the background check. I also understand that my volunteer position is not guaranteed, nor if granted, guaranteed for any length of time and that the Tournament may deny or end my volunteer opportunity at any time, for any reason, with or without prior notice.
